A1: See attached photos of existing vault. One of the existing conduits in the existing (12) twelve conduit package serves the fire pump underground. Fire pump conductors are run in the cable tray with the others. See notes 9.308 and 9.313 on sheet E100 for new fire pump work.

Q2: Please provide any photos of the existing vault.

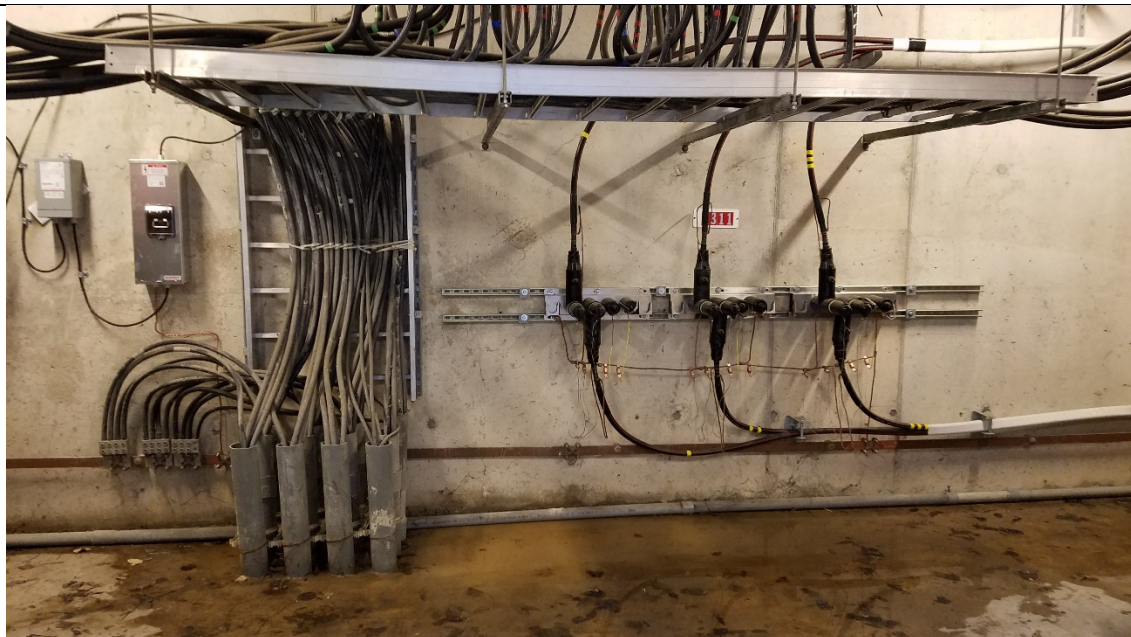

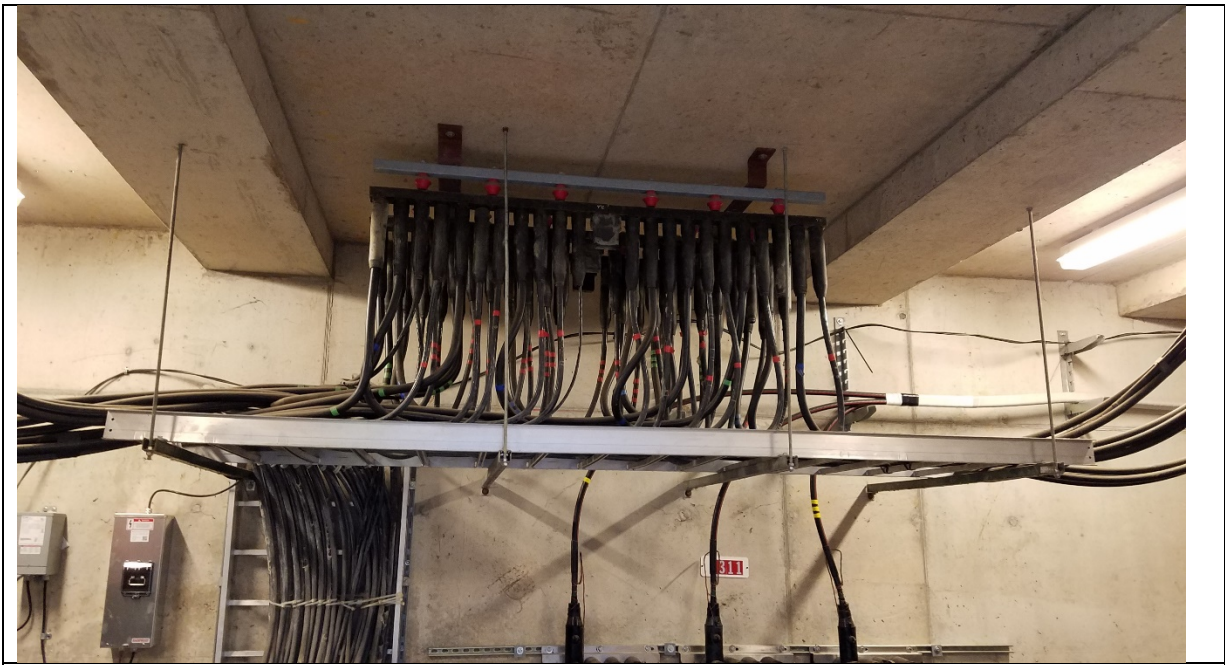
