1. Section 26 56 00

Page 2 - Item 1.04: Change to the following:

"Luminaires shall be provided with a five (5) year manufacturer's warranty covering LEDs and paint finish, manufacturer shall respond to site within ten (10) days' notice of potential warranty issues by Alliant Energy Center Staff."

Page 3 - Item 2.01.B: After the following paragraph, update series of potential approved substitutes.:

"The following series of alternate fixtures may be used provided luminaire meets or exceeds all requirements laid out in section 26 56 00 (Including the technical criteria listed for the specified Gleon units used as basis of design) and the construction documents. Bidder is responsible for ensuring specifications and requirements are met.

Page 5 - Item 2.02.C.4.e: Delete this item.
