“ Environmental consultant will provide a disposal profile and waste manifests for all previously identified contaminated materials on the site. ”

To:

“ Environmental consultant will provide a disposal profile and waste manifests for all contaminated materials identified on the site. ”

PLEASE NOTE THE FOLLOWING CONTRACTOR SUBMITTED QUESTIONS:

Q1: Who is paying the tipping fees at the landfill?

A1: All costs associated with project completion are covered by General Contractor. Refer to Sections 00 41 13, 00 52 96 & 01 74 19.

Q2: Section 31 00 00, Item 3.2.D.2. states “ previously identified contaminated materials” is there some sort of environmental report?

A2: Not in the RFB. See edit detailed in Item 2 above.

Q3: What landfill? Mad Prairie or Deer track?

A3: Only the Dane County Landfill. Refer to Sections 01 74 19, 02 41 16, & 31 00 00.

Q4: Will we be paid for extra trucking if we find contaminated soils?

A4: Yes, refer to revised Bid Form, issued with this Addendum.
