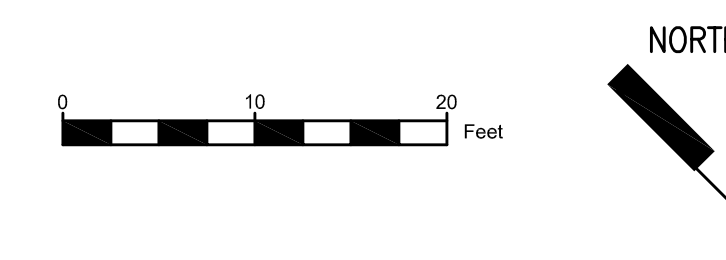


1 SITE PLAN AND GRADING PLAN

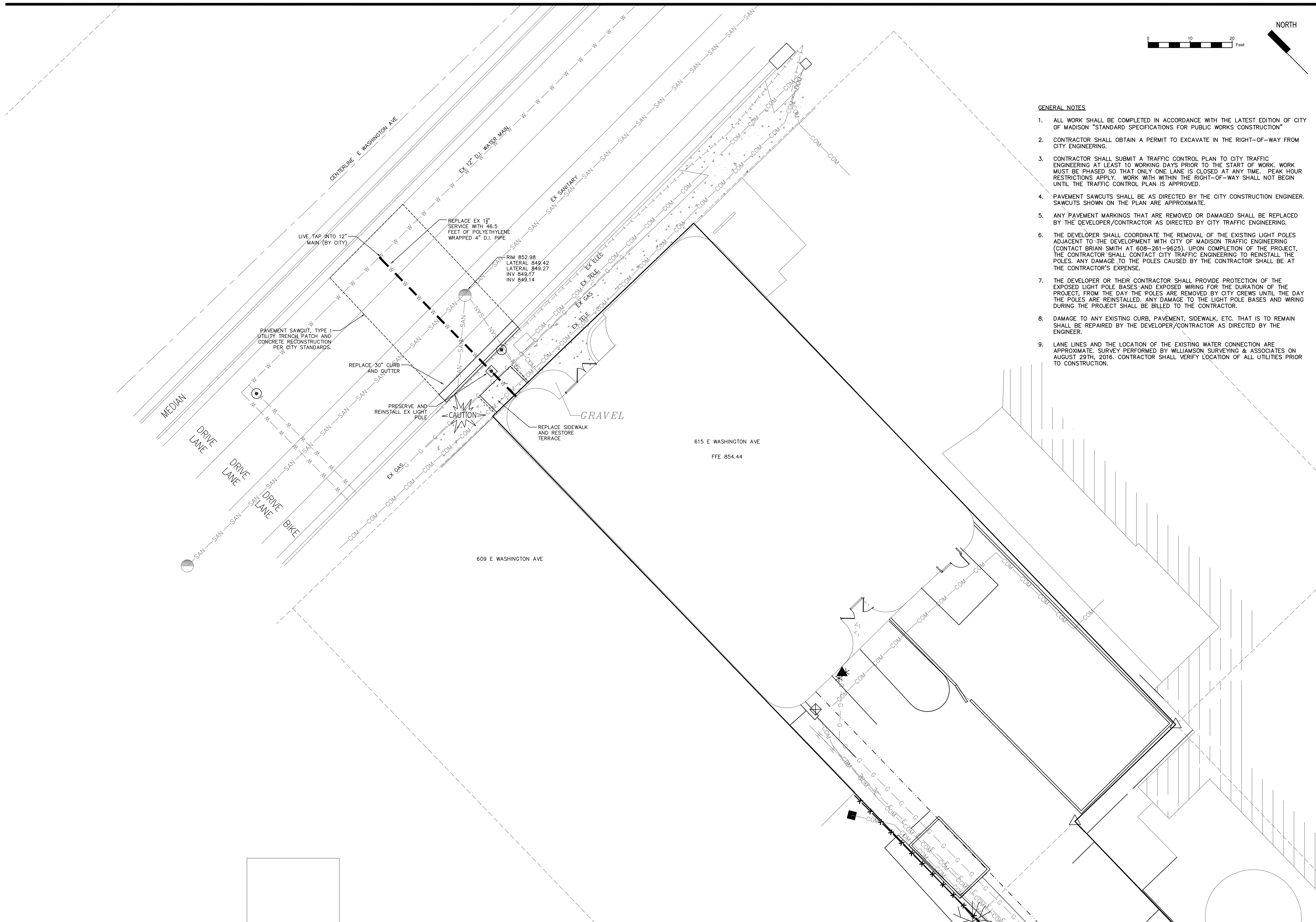

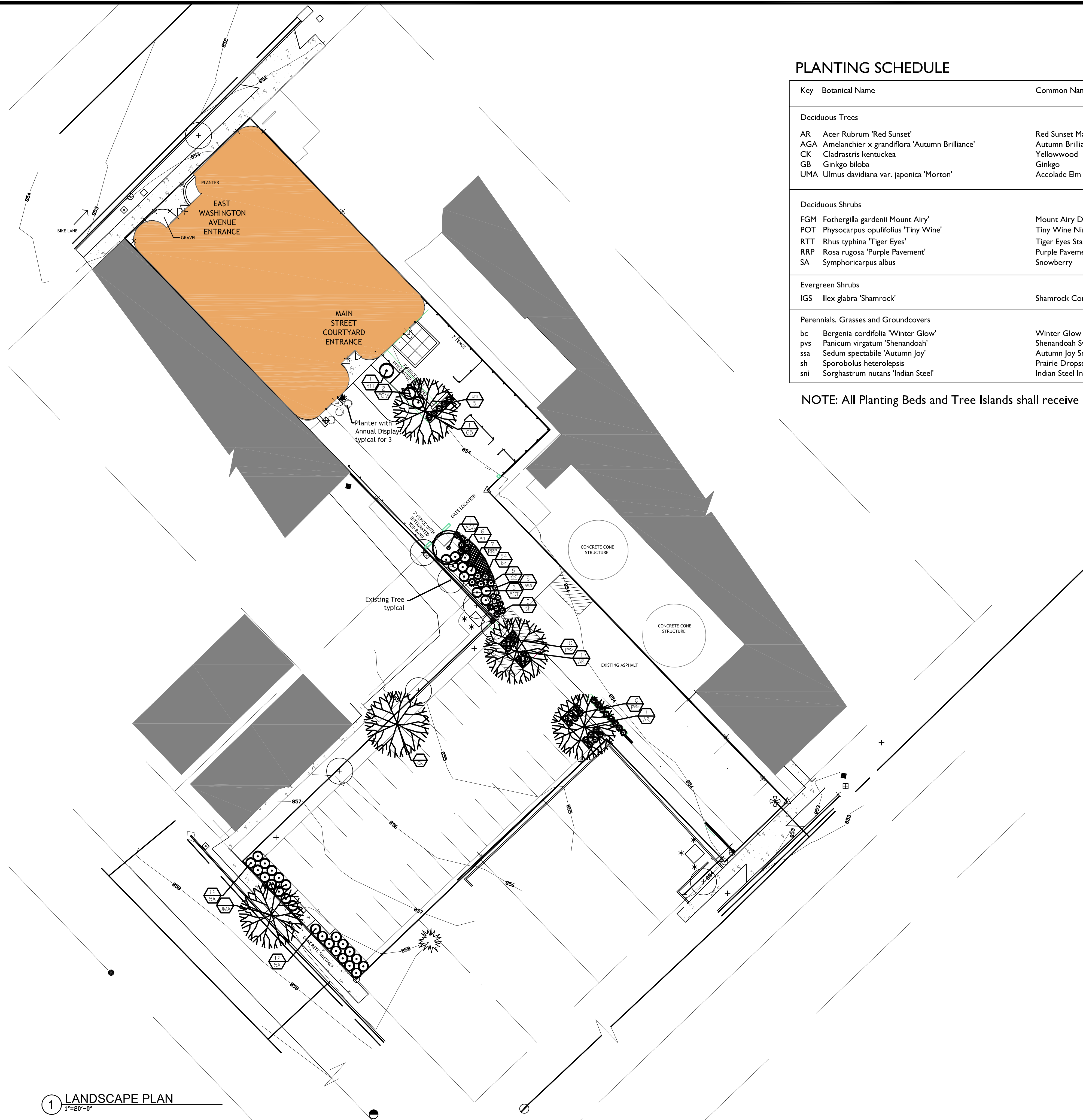




GENERAL NOTES

1. ALL WORK SHALL BE COMPLETED IN ACCORDANCE WITH THE LATEST EDITION OF CITY OF MADISON "STANDARD SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION"
2. CONTRACTOR SHALL OBTAIN A PERMIT TO EXCAVATE IN THE RIGHT-OF-WAY FROM CITY ENGINEERING.
3. CONTRACTOR SHALL SUBMIT A TRAFFIC CONTROL PLAN TO CITY TRAFFIC ENGINEERING AT LEAST 10 WORKING DAYS PRIOR TO THE START OF WORK. WORK MUST BE PHASED SO THAT ONLY ONE LANE IS CLOSED AT ANY TIME. PEAK HOUR RESTRICTIONS APPLY. WORK WITHIN THE RIGHT-OF-WAY SHALL NOT BEGIN UNTIL THE TRAFFIC CONTROL PLAN IS APPROVED.
4. PAVEMENT SAWCUTS SHALL BE AS DIRECTED BY THE CITY CONSTRUCTION ENGINEER. SAWCUTS SHOWN ON THE PLAN ARE APPROXIMATE.
5. ANY PAVEMENT MARKINGS THAT ARE REMOVED OR DAMAGED SHALL BE REPLACED BY THE DEVELOPER/CONTRACTOR AS DIRECTED BY CITY TRAFFIC ENGINEERING.
6. THE DEVELOPER SHALL COORDINATE THE REMOVAL OF THE EXISTING LIGHT POLES ADJACENT TO THE DEVELOPMENT WITH CITY OF MADISON TRAFFIC ENGINEERING (CONTACT BRIAN SMITH AT 608-261-9625). UPON COMPLETION OF THE PROJECT, THE CONTRACTOR SHALL CONTACT CITY TRAFFIC ENGINEERING TO REINSTALL THE POLES. ANY DAMAGE TO THE POLES CAUSED BY THE CONTRACTOR SHALL BE AT THE CONTRACTOR'S EXPENSE.
7. THE DEVELOPER OR THEIR CONTRACTOR SHALL PROVIDE PROTECTION OF THE EXPOSED LIGHT POLE BASES AND EXPOSED WIRING FOR THE DURATION OF THE PROJECT, FROM THE DAY THE POLES ARE REMOVED BY CITY CREWS UNTIL THE DAY THE POLES ARE REINSTALLED. ANY DAMAGE TO THE LIGHT POLE BASES AND WIRING DURING THE PROJECT SHALL BE BILLED TO THE CONTRACTOR.
8. DAMAGE TO ANY EXISTING CURB, PAVEMENT, SIDEWALK, ETC. THAT IS TO REMAIN SHALL BE REPAIRED BY THE DEVELOPER/CONTRACTOR AS DIRECTED BY THE ENGINEER.
9. LANE LINES AND THE LOCATION OF THE EXISTING WATER CONNECTION ARE APPROXIMATE. SURVEY PERFORMED BY WILLIAMSON SURVEYING & ASSOCIATES ON AUGUST 29TH, 2016. CONTRACTOR SHALL VERIFY LOCATION OF ALL UTILITIES PRIOR TO CONSTRUCTION.
