#### 11. Sheet A7.0

Door and Frame Schedule General Notes: Delete General Note 1 and replace with the following:

"1. Paint all HM Frames/Doors, including narrow lite HM frames on existing 3-0 x 7-0 to be reused, to match Owner's Sample."

Door and Frame Schedule General Notes: Add:

"5. Paint and prep by Owner at existing exterior window security frames to remain. Cleaning of existing aluminum frames to remain prior to installation of glazing by Owner."

Door and Frame Schedule: Add:

"Door 306a, Qnty 1, Door Size 3-0 x 6-8 x 1 ¾", WD, Elev A, Frame Matl HM, Elev A, Head and Jamb Detail 4A7.0, Hdwr Group 2."

"Door 354a, Qnty 1, Door Size 3-0 x 7-0 x 1 3/4", WD, Elev A, Frame Matl HM, Elev A, Head and Jamb Detail 4A7.0, 20 Min Fire Label, Hdwr Group 11, Remark 1."

"Door 354b, Qnty 1, Door Size 3-0 x 7-0 x 1 3/4", WD, Elev A, Frame Matl HM, Elev A, Head and Jamb Detail 4A7.0, 20 Min Fire Label, Hdwr Group 12, Remark 1."

#### 12. Sheet A8.0

Modify current Sheet A8.0 as shown on AD2.A8.0.1, issued with this Addendum. Reduced scope of work in Toilet 333.

Elevation 5A8.0: Add note: "Wall tile, type 2 at return walls of alcove."

#### 13. Sheet A9.0

Room Finish Schedule:

Revise Toilet 320 Wall Finish to East: PT-2. Revise all Toilet 333 Wall Finishes to PT-2.

#### 14. Sheet H1.0

Add fire damper in 96x18 new supply duct at fire rated wall into Corridor 3007. All supply and return duct penetrations shall have fire dampers provided and installed by HVAC contractor.

Delete Keyed Note 2 and revise with the following

Provide new enclosure for existing radiation. Enclosure to match existing enclosures. Prime and style as approved by Architect. STERLING MODEL SFA or equal, except at Room 300 provide new cover similar to STERLING MODEL JVB.

Add Keyed Note #2 to the following rooms: 311, 312, 313.

Delete Fire dampers associated with ductwork into and out of Office 300.

#### 15. Sheet H1.1

Add the following:

General Notes

RFB No. 108049 - 3 - rev. 07/05

- 1. HVAC Contractor has option to tie into steam and chilled water piping at 3<sup>rd</sup> floor ceiling, in the mechanical room or as indicated on plans.
- 2. Contractor to tie pumped condensate into condensate return at 3<sup>rd</sup> floor ceiling, NOT in 4<sup>th</sup> floor mechanical room.

#### 16. Sheet E1.0

Delete exit light at south end of Corridor 3008.

Revise exit light at intersection of 3007 and 3008 to type XA with arrows both sides pointing west.

Wire all exit lights to 3/X-2.

#### 17. Sheet E2.0

Add Wiring Detail-Special Outlet CP per AD2.E2.0.1, issued with this addendum.

In Mechanical Room 354, add these motors:

- 1. CIR-1,2: Each 3HP, 480 volts, 3 phase, wired to HP3-7, 9, 11 (20A, 3P breaker) 4#12-1/2"C. Starters will be furnished by DIV 15 for installation by DIV 16.
- 2. CP-1: 3/4 HP, 480 volts, 3 phase, wired to HP3-7, 9, 11 (20A, 3P breaker) 4#12-1/2"C. Starter will be furnished by DIV 15 for installation by DIV 16.

#### 18. Sheet E3.0

Light Fixture Schedule: Add Type A3 – identical to A but 2 lamp, 4 foot long.

Symbols List: Add per AD2.E3.0.1, issued with this addendum.

#### 19. Sheet E3.1


Panel Schedule:

- 1. In LP3/1 add note "All breakers feeding Special Outlets CP shall be multipole if the circuit is multiwire.
- 2. In HP3 add (1) 20A, 3P breaker and delete (3) 1P spaces.
- 3. In 3/X add (2) 20A, 1P breaker.



DRAWING THIRD FLOOR PLAN






ENLARGED PARTIAL THIRD FLOOR PLAN




ENLARGED PARTIAL THIRD FLOOR PLAN
