1. Section 00 41 13 – Bid Form

Delete current Section 00 41 13 – Bid Form and replace with new Section 00 41 13 – Bid Form, issued with this Addendum.

The alternate bid to pulverize existing asphalt is being deleted and replaced with new alternate bids with scaled down scope.

2. Section 01 10 00 - Summary

Delete paragraph 1.06-B-2 and replace with new paragraph 1.06-B-2:

"Payment will be made at the contract lump sum price and shall include all labor, materials, and equipment necessary to complete the specified unclassified excavation including, concrete pavement, curb and gutter, sidewalk, stripping and stockpiling topsoil, clearing, grubbing and disposal of plant material, cutting and filling to the required subgrade contours and sections, compacting, compaction testing, proof rolling, and disposition of excess soil material."

Delete paragraph 1.06-B-3 and replace with new paragraph 1.06-B-3:

"Removing concrete pavement, curb and gutter, sidewalk, saw cutting, stripping and stockpiling topsoil, clearing and grubbing, and finish grading of street subgrade are incidental to the unclassified excavation unless separate bid items are included on the Bid Form."

Delete paragraph 1.06-F-2 and replace with new paragraph 1.06-F-2:

"Payment will be made at the contract unit price per ton and shall include all labor, materials, and equipment necessary to furnish and install AC pavement including tack coat, asphaltic material, placement, compaction, and testing."
