NEW BADGER PRAIRIE HEALTH CARE CENTER

BIDS DUE: THURSDAY, JUNE 5, 2008, 2:00 PM. DUE DATE AND TIME ARE CHANGED BY THIS ADDENDUM.

This Addendum is issued to modify, explain or clarify the original Request for Bid (RFB) and is hereby made a part of the RFB. Please attach this Addendum to the RFB.

This Addendum only addresses two topics: 1) change of the Bid Opening date; & 2) alterations of the site / civil work associated with the stormwater management on the west side of the property.

PLEASE MAKE THE FOLLOWING CHANGES:

1. Project Manual Cover (Volumes One, Two & Three)

Change: "Opening Date: **THURSDAY, MAY 22, 2008**", to: "Opening Date: **THURSDAY, JUNE 5, 2008**" on each volume cover.

Change: "Location: **PUBLIC WORKS OFFICE**", to: "Location: **MAIN DINING ROOM, WEST WING BLDG, BADGER PRAIRIE HEALTH CARE CENTER**" on each volume cover.

2. Project Manual Cover (Volume Two only)

Delete: "**PROCUREMENT AND CONTRACTING REQUIREMENTS**" reference.

3. Bid Form

Page BF-10: Delete current page BF-10; add new page BF-10, issued with this Addendum.

Another entry is added to include the stand-alone cost add or deduct for Addendum No. 1 work.

4. Sheet C2

Delete current Sheet C2; replace with new Sheet C2, issued with this Addendum. To be printed to correct scale, plot all sheets on 30" x 42" (E1) paper.

- West entry road added. This Contractor to grade to subgrade elevation. Aggregate base, curb & gutter, & asphalt pavement by others (N.I.C.).
- Future Ice Age Trail location modified. Work by others (N.I.C.).

- West detention basin moved.
- Storm piping and structures draining to west detention pond modified.
- Drainage swale north of new west entry road moved west.
- Bioretention basin BR10 added.
- Disturbed area limits increased.

5. Sheet C3

Delete current Sheet C3; replace with new Sheet C3, issued with this Addendum.

- All storm sewer piping draining west detention basin modified.
- Existing CMP pipe to be removed entirely instead of connected to.
- Bioretention basin BR10 underdrain added.
- Inlets & storm piping added to new west entry road.

6. Sheet C4

Delete current Sheet C4; replace with new Sheet C4, issued with this Addendum.

- Drainage swale north of new west entry road moved west.
- Stone weeper locations adjusted to match new detention basin location.
- Erosion mat areas adjusted to match new detention basin & drainage swale locations.
- Silt fence locations adjusted to match new disturbed area limits.
- Inlet protection added to new inlets on new west entry road.
- Stone outlet protection locations & sizes adjusted to match new storm sewer locations.

7. Sheet C5

Delete current Sheet C5; replace with new Sheet C5, issued with this Addendum.

- Profile for new west entry road added.

8. Sheet C7

Delete current Sheet C7; replace with new Sheet C7, issued with this Addendum.

- Adds detail 18/C7.

9. Sheet C9

Delete current Sheet C9; replace with new Sheet C9, issued with this Addendum.

- Revises detail 2/C9.
